ADDENDUM TO MEMORANDUM OF UNDERSTANDING REGARDING CHARTER SCHOOL OVERSIGHT AND OPERATIONS by and between

LAKESIDE UNION SCHOOL DISTRICT AND BARONA INDIAN CHARTER SCHOOL

This Addendum to the Memorandum of Understanding ("Addendum") is entered into by and between the Lakeside Union School District ("District") and Barona Indian Charter School, Inc. ("BICS"), a California nonprofit public benefit corporation operating the Barona Indian Charter School ("Charter School") under the District's oversight. District and BICS are collectively referred to herein as the "Parties."

RECITALS

WHEREAS, the Parties previously entered into an Memorandum of Understanding regarding Oversight and Operations with a term running coterminous with its renewal charter petition through June 30, 2024 ("MOU");

WHEREAS, Education Code section 47607.4 was added and subsequently amended to specify that all charter schools with a term expiring on or between January 1, 2022 and June 30, 2025, shall have their term extended by two additional years; and all charters with a term expiring on or between January 1, 2024, and June 30, 2027, shall have their term extended by one additional year;

WHEREAS, per Education Code section 47607.4, the Charter School's current term has been automatically extended through June 30, 2025; and

WHEREAS, the Parties desire to amend the MOU to extend its term for one (1) additional year to align with Charter School's extended charter term.

NOW, THEREFORE, in consideration of the covenants and agreements set forth in this agreement, the Parties agree to the following:

AGREEMENT

- 1. <u>MODIFICATIONS TO TERM OF MOU</u>. The term of the MOU shall be extended for one (1) additional year running through June 30, 2025, unless earlier terminated in accordance with the terms of the MOU.
- 2. <u>ORIGINAL MOU IN EFFECT</u>. Except as expressly amended by this Addendum, the Parties acknowledge and affirm that the terms, obligations, and conditions of the MOU shall remain in full force and effect and binding upon them.
- 3. <u>EXECUTION IN COUNTERPARTS</u>. This Addendum may be signed in counterparts such that the signatures may appear on the separate signature pages. Signature of copies of this Agreement transmitted by facsimile or electronic mail to other Parties to this Agreement,

and/or signed electronically by either/both Parties, shall have the same force and effect as signature of the original.

4. <u>AUTHORITY/SUBJECT TO RATIFICATION</u>. Each person below warrants and guarantees that she/he is legally authorized to execute this Addendum on behalf of the designated party and that such execution shall bind the designated party to the terms of this Amendment #1 subject to ratification by the Parties' respective governing boards.
